Any veteran or surviving widow may qualify if one or more of the following needs exist:

- › Assistance with bathing and other hygienic needs
- › Assistance with dressing or undressing
- › Assistance attending to the wants of nature
- › Assistance eating
- › Assistance with the adjustment of any special prosthetic or orthopedic device
- › Being legally blind in both eyes (5/200)
- › Or, any physical or mental incapacity that requires ongoing supervision and assistance for safety.

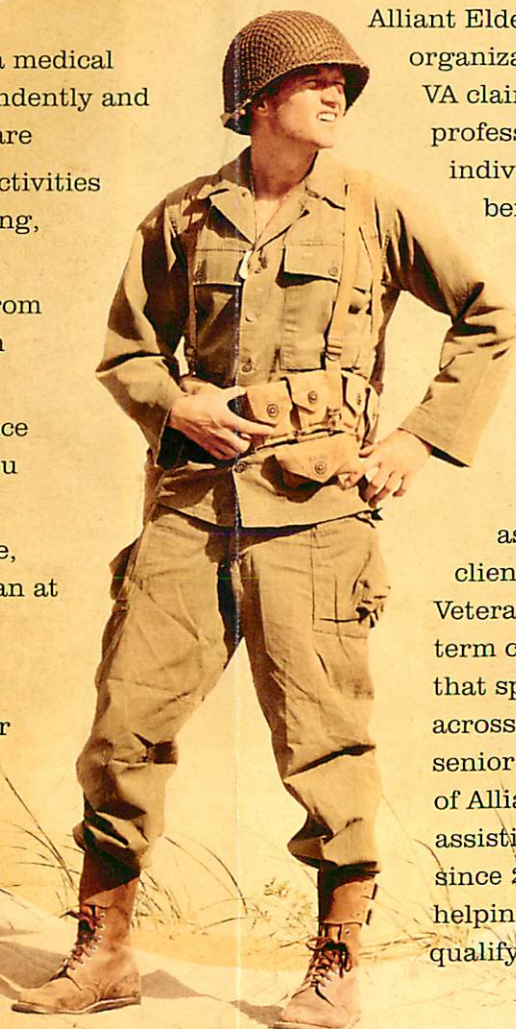
This Special Program

The purpose of this special program is to provide financial assistance to wartime veterans or their surviving spouse who require assistance with routine activities of daily living, but do not have the financial means to pay for their care.

Eligibility for Aid and Attendance

- › Veteran must have served at least 90 days of active duty with at least one day served during a time of war
- › Medical need—there must be a medical reason you cannot live independently and need regular assistance and care
- › Do you need assistance with activities of daily living (bathing, dressing, safety, etc)?
- › Will the assistance you need from other people be required on an ongoing basis?
- › Do you need financial assistance to help you pay for the care you require?
- › If you are the surviving spouse, were you married to the veteran at the time of his/her death?

If you answered yes to the above questions, you may be eligible for financial assistance through a special pension program administered by the Department of Veterans Affairs.



Improved Pension with Aid and Attendance

This pension is based on medical and financial need. It is a tax-free benefit that pays qualified individuals each month **up to:**

Veteran and Spouse	\$2,120
Single Veteran	\$1,788
Surviving Spouse	\$1,149
